Voters to Decide Fate of Measure J in Tuesday's General Election

► If approved, the measure would provide \$574 million for construction projects — including renovation of SEM and Fine Arts.

Voters on Tuesday will determine if Cypress College will be able to undertake a much-needed renovation of the Science, Engineering, and Math Building — a project that has been years in the waiting — along with several other major projects that include the Fine Arts Building and a new Veterans Center.

Measure J, if approved by a 55% or higher margin, would provide \$574 million in revenue to the North Orange County Community College District for construction projects here and at Fullerton College.

The measure was placed on the ballot by NOCCCD Trustees in July and is backed by Supporters of Fullerton and Cypress Colleges

Please Advise Students of Recent Bike Thefts and Safety Tips

A series of bicycle thefts have occurred this month. Typically, the suspect brings a bike to the bike rack, cuts the lock off a “chosen” bike, and a second suspect then rides away with the bicycle that the original suspect arrived on, according to Campus Safety Director Sheryl Smith.

Here are some tips to share with students to help prevent bicycle theft:

- Always lock your bicycle through the frame and both wheels to a bicycle

Yes on J, a non-profit political action committee. There is no formal opposition to Measure J, though a group of local taxpayers have expressed concern about the measure.

Measure J has been endorsed by CSEA, United Faculty, the Cypress College Academic Senate, the Cypress College Veterans

Organization and a number of other external organizations, including the chambers of commerce in both Cypress and Fullerton. External support from individuals includes endorsements from U.S. Representative Loretta Sanchez, State Senator Lou Correa, Assemblyman Tom Daly, along with several local elected officials, veterans, and business, civic, and education leaders.

Bicycle Safety Tips

Bicycle theft has become a notable problem on college campuses, and Cypress College is no exception. Bicycles — and individual bicycle parts such as seats and “quick release” wheels — are in big demand for would be criminals. Every set of bike racks is currently covered by a security camera. These cameras have helped Campus Safety and local police capture suspects in the past. As the college explores additional ways to help reduce theft, we are sharing tips to limit the window of opportunity for would-be bicycle thieves:

Secure Your Bicycle

- It has been found that in the vast majority of bicycle thefts, bicycles were unlocked, improperly locked, or locked with inadequate locking devices, such as lightweight cables or chains, or low-quality U-lock devices.

The following tips may be helpful to deter a perpetrator from committing theft:

- ✓ You should **always lock your bicycle** through the frame and both wheels to a bicycle parking rack, preferably a rack with a thicker frame.
- ✓ Lock all free parts of the bicycle as well, or take them with you. If you lock only the front wheel you may return to find only the front wheel.
- ✓ You should always **carry a secure lock** whenever you plan to leave your bicycle unattended.
- ✓ The **“U”-shaped locks** have proven to be the most effective; but, like all locks or chains, they can be defeated. Use a high-end “U”- shaped lock to reduce the chances of the lock being defeated. You should also exercise care in where and how you lock your bicycle.
- ✓ Leave your bicycle in a **visible, well-lighted area**. Avoid leaving your bicycle locked outside overnight.
- ✓ Always **use designated bike racks** rather than light poles, railings, benches, or other unsecured places. Suspects are often creative in their approach; if they are unable to steal the bike, they may try to take any valuable parts.

Report Theft

- ✓ Report the theft immediately to the Cypress College Campus Safety Department.
- ✓ Provide campus safety staff with the descriptive information, such as the serial number and license number, to increase the chance of recovery.

Important Dates

UC Application:

The application website is open from August 1st to November 30th. You can submit our application beginning November 1st.

CSU Application: The application website opens on October 1st. The priority submission time is October 1st to November 30th. After November 30th some schools or specific programs within a school may close for applications. Send transcripts after fall grades are posted.

UC Application Update: You must update your application as soon as your fall semester grades are on your transcript. The deadline date will be sent to you by email.

Independent Colleges and Universities:

Deadlines vary. See individual school website for dates.

Financial Aid: Submit your FAFSA between January 2nd and March 3rd.

Student Intent to Register (SIR): June 1st or one month after acceptance letter is sent if later than May 1st. An exception is San Diego State University where the SIR is due May 1st.

Transfer Applications Due

October 1st through November 30th is the priority period for submitting applications to the California State University (CSU). November 1st to 30th is the priority period for submitting to the University of California (UC). This means that all applications submitted during this period will be reviewed. After this time, the universities can stop accepting applications if they have reached their target numbers. They may stop accepting all applications or stop accepting applications for specific majors while remaining open for other majors.

Both university systems require students to complete and submit their applications online. The CSU application website is located at www.csumentor.edu. The UC application is at www.univeristyofcalifornia.edu/apply. Both sites have instructions and tips for completing the applications. Both also have application status pages that give students information about open and closed majors as well as open and closed campuses.

Getting an Associate Degree for Transfer can make it much easier for you to transfer to a CSU. The Associate Degree for Transfer (AD-T) is a special degree offered at the California Community Colleges to facilitate transfer to CSU and gives students some priority for admission. With an AD-T students may be given a slight bump in GPA for admissions purposes when applying to an impacted campus or an impacted major. To pursue an AD-T, students should meet with a counselor to develop an education plan that puts them on the path towards the AD-T degree.

The guarantee means that students who earn an AD-T are guaranteed admission to a CSU in a similar major but not necessarily to a particular campus. In addition, once at the CSU, students enrolled in a designated similar degree program are guaranteed to be able to complete the bachelor degree in only 60 units. Counselors can help determine which CSUs offer bachelor degrees that correspond to the AD-Ts.

Cypress College currently has 19 approved AD-Ts. Eligible students, who are ready to transfer, should apply for the degree in Admissions and Records by the beginning of the Spring semester. Evaluators will verify completion of the degree online.

Several more Associate Degrees for Transfer are in the approval process and will be available Fall 2015. Check the Cypress College 2015–2016 Catalog for information on the new degrees.

UCLA Hosts TAP Conference

UCLA will host approximately 2,000 potential transfer students at their annual TAP (Transfer Alliance Program) Conference on Friday Nov. 13th. The conference runs from 8:30 AM to 3:00 PM and is held in **UCLA Ackerman Union and Kerckhoff Hall**. The conference provides attendees an opportunity to learn more about UCLA; and helps prospective students prepare for a successful transfer. Students will be able to attend workshops, talk with representatives from the academic departments and tour the campus.

The conference is free but Students must preregister at: www.tap.ucla.edu/conference.htm before Nov. 9th. Prior to attending the conference, all students must complete a Field Trip Liability Form in the Transfer Center located on the second floor of the Student Center. They must also provide their own transportation, lunch and parking fees. Parking is \$12 and lunch is \$5 - \$15 on campus.

Transfer Guarantee to ASU

Designed for California community college students, the Guaranteed Program for Admission helps you stay focused on earning your undergraduate degree and plan for a smooth transfer to Arizona State University. It offers the following benefits:

- guidance from ASU on which courses to take while attending your community college
- priority consideration for ASU's New American University Scholarship program upon admission to the university
- acceptance of IGETC or CSU GE course work toward meeting the associated ASU lower-division general studies requirements
- transfer of any articulated course work to ASU

General university admission is guaranteed upon successfully meeting one of the following conditions:

- completion of at least **24 transferable semester credits** with a minimum cumulative transfer GPA of 3.00 plus either a final **high school transcript** or GED
- a fully certified **IGETC or CSU GE** with a minimum cumulative transfer GPA of 2.50 plus either a final **high school transcript** or GED
- an **associate degree** with a minimum cumulative transfer GPA of 2.50

NEWS FROM THE BOARD OF TRUSTEES

A Summary of the Board Meeting of October 28, 2014

Comments from the Audience

Mortuary Science Baccalaureate Degree – Both **Steve Crawford**, Cypress College Mortuary Science student, and **Glenn Bower**, Director of Mortuary Science at Cypress College, spoke in support of the department applying to be a part of the SB 850 pilot program which would introduce baccalaureate degrees at community colleges.

Measure J Update – District Director of Public and Governmental Affairs **Kai Stearns Moore** gave an update on the status of the Measure J political campaign, including that over \$324,000 has been raised by the Supporters of Fullerton and Cypress Colleges Yes on J, and that new notable endorsements include the Fullerton College Associated Students and the Cypress College Academic Senate. With less than one week left, she said that phone banking volunteers are still needed and that people can sign up at www.SupportOurColleges.com.

Yes on Measure J – Several Cypress College students addressed the Board about Measure J, NOCCCD's upcoming ballot measure. **Wilson Peng**, former Cypress College AS member spoke about working for the Yes on Measure J campaign and his efforts to inform students about the facility needs at the District. Student **Luis Raprager**, along with **Chris Wright**, President of the Cypress College Veteran's Organization, thanked the Board for putting Measure J on the ballot and spoke about the current space constraints on the Veteran's Resource Center.

Chancellor's Report

Reports – **Julie Kossick**, District Director of Human Resources, and **Danielle Heinbuch**, Administrative Support Manager of Human Resources, reported on "NOCCCD's Institutional Commitment to Diversity: Five-Year Report." **Dr. Cherry Li-Bugg**, Vice Chancellor of Educational Services and Technology, presented information on "SB850: Bachelor's Degree Pilot – NOCCCD Board Deliberations.

Superintendents/Principals Breakfast – Approximately 50 attendees from local high schools and districts attended the annual breakfast and enjoyed presentations from Facilities Director **Albert Miranda** and Hotel and Restaurant Management Department Coordinator **Lisa Clark**. Information was also shared on the successful Boost initiative... **OC Career Pathways Partnership Grant** – Cypress College will receive \$503,640 of the \$15 million Orange County Career Pathways Partnership Grant, thanks to the leadership of **Dr. Steve Donley**... **CTE Enhancement** – The College will also tentatively receive an allocation of \$460,000 from the CTE Enhancement fund established by Governor Brown in the 2014-15 state budget. Funds can be used for equipment, curriculum development, professional development, and other related costs necessary to develop, enhance, retool, and expand quality career technical education offerings... **Bachelor's Degree** – The College plans to submit for consideration by the District a proposal to establish a bachelor's degree for Mortuary Science... **Carol Ridley** – Administrative Assistant **Carol Ridley** unexpectedly passed away over the weekend.
