VIII. Faculty Issues – Unfinished Business

- a. CTE Medals for Graduation (5 minutes) Michael Klyde
The CTE Division would like to have Senate approval for the graduates to wear medals at graduation.

- b. Resolution in Support of Funding the Theater (10 minutes) Liana Koeppel

The Senate will be presented a resolution coming from the Instructional Program Review Committee in support of funding the Theater. This will be a first read.

- c. Update on the state of curriculum at our college. (15 minutes) Silvie Grote
This will be an interactive demonstration of curriculum management system and available resources and reports to assist faculty in the curriculum process.

- d. Campus Technology Update (15 Minutes) Peter Maharaj
Campus Technology Liaison will update the senate on several developments of interest to faculty. The senate will be presented with information related to: a computer refresh and revision of the current operating plan; changes to the Technology Master Plan to include classroom upgrades; and general technology and Construction Updates.
